Message from the Executive Director


From the Executive Director


This 2015 Annual Report gives us an opportunity to look back on a year of growth and change for Harmony Hill.

Thanks to your support, Harmony Hill had an incredible year—serving more in our cancer programs than ever before—with 356 people served in our core 3-day cancer retreats, compared to 257 in 2014. Overall, we reached over 5,000 individuals in our 3-day retreats, offsite programs and webinar views.

Also in 2015, we kept our administrative and fundraising expenses to 17.5% of our overall expense budget (from 21.3% in 2014), representing a focus on efficiency. We also were able to generate a surplus in 2015, with that surplus applied to clearing the last of our long-term debt acquired in our capital expansion in 2008.

Because of your generous and unwavering support, we also increased our small donations (defined as anything less than \$10,000) by a healthy 18% in 2015 compared to 2014. This represents how much you support Harmony Hill's mission: to transform the lives of those affected by cancer and to inspire healthy living for all.





2015 Ending Net Assets: \$3,072,705

We owe all of this to your support and advocacy. Positive numbers, however, are just indicators—they do not tell how lives of individuals and families were transformed because of the work you enabled us to do in 2015.

That transformative work continues in 2016—this year we expect to serve even more people in our programs than in 2015. This year also brings many new opportunities to expand our work in collaboration with local hospitals—bringing Harmony Hill's expertise in survivorship programs to bear in the broader arena of cancer survivorship.
