A MESSAGE FROM THE DIRECTOR

We are happy to share with you Harmony Hill's 2017 Annual Report, reflecting the many ways we have been able to serve our mission, and to honor the generosity of our donors through that work.

While celebrating the 31st year of our cancer programs, 2017 marked a year of broadening our program base to include more cost based wellness programs and hospital program partnerships to improve our financial support for a higher volume of cancer retreats. Our mission, is expressed in every activity we undertake, both through our cancer retreats, our wellness retreats and balanced living events. By the end of 2017 we had provided a total of 230 cancer retreats throughout our history and have served thousands of people impacted by a cancer diagnosis.

Highlights specific to 2017 include:

- Served 323 individuals in no charge cancer retreats, the heart of our program.
- Grew the Health Professional Renewal program substantially, serving providers across the region--including 30 nurses from 10 regional hospitals or organizations in Harmony Hill's first two Nurse Renewal retreats for continuing education credits.
- Served 246 individuals in off campus hospitals and clinics in the Puget Sound region through Harmony Hill's innovative Cancer Wellness programs.
- Served 404 people in yoga and wellness offerings at Harmony Hill.

- Over-all we directly served 1.003 individuals through all our cancer and wellness program, reflecting a 38% increase over 2016. Please note that our health professional and hospital programs generated earned revenue for Harmony Hill, while allowing us to more broadly serve our mission.

We did all of this while keeping our administrative and fundraising expenses to 21% of our overall expense budget.
